## U.S. BANK STADIUM SWEEPSTAKES - OFFICIAL RULES

## NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.

**Eligibility**: The U.S. Bank Stadium Sweepstakes (the "Sweepstakes") is open to individuals who are at least 18 years of age. Entrants are subject to all applicable federal, state and local laws and regulations. Void where prohibited by law.

**Entry Period**: The Sweepstakes begins on Tuesday, October 7, 2025 at 10:00 a.m. CT and ends on Thursday, October 9, 2025 at 11:59 p.m. CT (the "Entry Period"). Entries received before or after the Entry Period are void. Sponsor's computer systems are the official timekeeping device for the Sweepstakes.

All eligible entries submitted by entrants will be entered in a random drawing to determine the prize winner ("Prize Winner") by the means set forth below.

By entering, all entrants consent to the use by Sponsor of all the information provided in the entries for marketing and/or sales promotional purposes without any attribution, identification, right of review or compensation.
